**IMPORTANT** - Read this License Agreement carefully before clicking on the “Agree” button in our web shop or using our software installers. By clicking on the “Agree” button, you agree to be bound by the terms of the License Agreement following this paragraph.

## END USER LICENSE AGREEMENT

**THIS IS A LEGAL AGREEMENT** between you (either an individual or an entity) and Huslik Verlag GmbH. By clicking on the “Agree” button, you are agreeing to be bound by the terms and conditions of this License Agreement. If you do not agree to the terms and conditions of this License Agreement, do not click on the “Agree” button.

### 1. Grant of Limited License

Huslik Verlag GmbH grants to you the nontransferable, non-exclusive, limited right to install and use the software program downloaded or contained on the CD-ROM (the “Software”). The license permits the licensee to install and use the Software on up to 5 (five) machines. However, a single license does not allow multiple users to ever use Software on one or multiple machines, regardless of whether such use is concurrent. In other words, every user needs its own license.

### 2. Copyright

The Software is owned by Huslik Verlag GmbH and is protected by German, European, and United States

copyright laws and by international treaty provisions. You should therefore treat the Software like any other copyrighted material (such as for example, books or musical recordings). Among other things, copyright laws prohibit you from making derivative works of the Software. You may, however, make copies of the Software solely for your individual and personal use on multiple computers, provided that you do not copy the Registration Key (see Section 3(a) below) and further provided that you include all copyright and proprietary rights notices on any copies. Notwithstanding the foregoing, you may not make copies for use on multiple machines if multiple users (including employees, agents, or contractors) will use those machines unless you purchase a corresponding number of seat licenses.

### **3. Other Restrictions**

You shall, at your own expense, promptly enforce the restrictions in this License Agreement against any person who gains access to your copy of the Software (i.e. the copy you obtain upon agreeing to this License Agreement or any other lawful copy you have made from this copy) with your permission or while your employee and who violates such restrictions, by instituting and diligently pursuing all legal and equitable remedies against him or her. You agree to immediately notify Huslik Verlag GmbH in writing of any misuse, misappropriation or unauthorized disclosure, display or copying of the Software that may come to your attention. You agree to indemnify

and hold harmless Huslik Verlag GmbH from any and all claims resulting from your use of the Software or breach of this Agreement.

### **7. Terms of Service**

If you downloaded the Software, Huslik Verlag GmbH servers will automatically log certain non-personal information from your computer, information such as your IP address. If you decide you wish to purchase a Registration Key, we require that you provide us with certain billing information that is personal to you (“Personal Information”). That Personal information includes your name, address and credit card number and may also include other information such as your e-mail address. After we have received payment from your credit card company, we save only the last five digits of your credit card for identification purposes.

To the extent Huslik Verlag GmbH may access Personal Information, Huslik Verlag GmbH will not transmit Personal Information voluntarily to any third party without your express consent. Your Personal Information remains in your full control.

Huslik Verlag GmbH may, on occasion, use your IP address to help diagnose problems with our server and to administer its web site. Huslik Verlag GmbH may derive general information from your Personal Information and web usage. Huslik Verlag GmbH will not voluntarily disclose, sell or

trade your Personal Information to any third party without your consent.

### **8. Export Law Assurance**

This Agreement shall be governed by the laws of Germany, including the 1980 United Nations Convention on Contracts for International Sale of Goods. Venue for any action under this Agreement shall be in Augsburg, Germany. You consent to the personal jurisdiction of the courts of such venue. This License Agreement is the complete agreement between Huslik Verlag GmbH, Kopernikusstr. 67, 86179 Augsburg, Germany and you and supersedes all prior agreements, oral or written, with respect to the subject matter hereof.
